

### EXTEND YOUR FIRE PIT SEASON

Designed to work with our Outpost™ Rod, the Breeo Heat Deflector is purposefully designed to maximize hot airflow out from the fire pit to keep you warm. It is the ONLY adjustable heat deflector available today, and is built to outperform and outlast other heat deflectors on the market. Experience our heatwave technology and stay warm by the fire the whole year 'round.



### **FEATURES**

**INCREASED WARMTH:** Design elements such as the heat focusing cone, downdraft bends, and secondary heat chamber efficiently direct heat out away from the fire laterally, keeping you warmer in your seat.

**ADJUSTABLE HEIGHT:** Compatible with the Outpost Rod, the heat deflector is height adjustable, allowing you to move it up and down on the rod, impacting the amount of heat directed outward.

**BUILT TO LAST:** Constructed out of 304 stainless steel and made by Breeo in the USA, the Outpost Heat deflector will last a lifetime in the elements.

**NOTE:** The 19 and 24 heat deflectors require one Outpost Rod, (same Rod that comes with our Outpost Grill) the 30 heat deflector has two handles and requires two Outpost Rods. Heat Deflector gets very hot when over the fire, use high-quality fire-protective gloves when handling.

### **INSTALL OUTPOST ROD**


# 1 INSERT THE OUTPOST ROD

Insert the locking mechanism end of the Outpost Rod into the opening on the rim on your fire pit. Align the pegs on the rod with the notched openings on the fire pit, lower rod, ensure pegs go down into the opening and twist the rod to secure.



Slide the locking collar on the Rod down, align tabs and slide them into the notched openings on the fire pit. This will lock the post into place. The Rod should not spin once locked, and the small handle should be facing outward.





### **USE AND CARE**

Make sure the Heat Deflector is secured firmly into place on the Outpost Rod to prevent sliding down while in use. Soot can build up on the underside of the Heat Deflector, clean with a rag, water, and dish soap. Stainless steel may darken in color when exposed to heat. This will not affect performance. Heat Deflector can be used in conjunction with other Outpost accessories if desired. Heat Deflector can be used to protect the fire pit from light rain.

### **INSTALL HEAT DEFLECTOR**

## 1 PREPARE FOR INSTALL

Loosen the locking thumb screw (do not remove) so that the sleeve can slide onto the Outpost Rod. For the X30 Heat Deflector, there are two of these.



Hold the Heat Deflector horizontally and slide the sleeves onto the Outpost Rod. If using the X30 heat deflector this should be done by two people, one at each handle. Lower the heat deflector to the desired height and secure by tightening the locking thumb screw(s) on the handle.





# 3 ADJUSTING THE HEIGHT

You can adjust the height of the heat deflector as needed to ensure you get the full benefits of the increased heat depending on if you're sitting or standing.



### **WARNING**

Always practice safety first when using the Outpost™ system and accessories, exercise the same precautions you would with any open fire.

Never leave your Breeo fire pit & accessories unattended, especially around children and pets.

The Outpost Heat Deflector, Rod, and accessories become very hot in use and can cause severe burns. Do not touch when hot

Avoid touching sensitive surfaces with the Outpost Heat Deflector and accessories when they are hot.

When adjusting the height of your Outpost Heat Deflector, always wear protective gloves or use other heat protection to avoid burns.

The X30 Heat Deflector puts out a lot of heat laterally, make sure there are not any combustible or meltable surfaces close-by.





#### WARRANTY

Breeo, LLC warrants to the original purchaser that the Breeo Fire Pits and Accessories are free from workmanship and material defects during the lifetime of the original purchaser. In addition Breeo, LLC warrants no rust through or burn through for a period of five (5) years from purchase. If a product is covered by this limited warranty, Breeo, LLC, at its option, will repair or replace with a new product free of charge, excluding any applicable shipping and handling charges. If the product being warranted has been discontinued, the replacement product will be of equal or similar value.
